



Evaluation of the National Professional Enquiry Project (NPEP) - Online survey

The Welsh Government has funded Bangor University to explore and curate the National Professional Enquiry Project (NPEP) reports. This research will also investigate their accessibility for practitioners and researchers.

As part of this stage of the research, Bangor University is seeking to carry out a survey with practitioners involved in NPEP.

The survey will involve schools answering questions around the NPEP project. The research team will use Jisc online survey tool and the survey should not take longer than 15 minutes. Surveys can be accessed in either Welsh or English, depending on the participant's preference.

The Welsh Government is the data controller for the research. However, Bangor University will delete any personal data provided and anonymise the raw data before it is shared with the Welsh Government.

Your participation is completely voluntary. However, your views and experiences are important to help inform this Welsh Government research project and Welsh Government policies.

Privacy Notice

What personal data do we hold and where do we get this information?

Personal data is defined under the UK General Data Protection Regulation (UK GDPR) as 'any information relating to an identifiable person who can be directly or indirectly identified by reference to an identifier'.

The Welsh Government has provided Bangor University with your contact details (name, email address, and telephone number) as an individual who has a professional interest in the subject of the research. The Welsh Government holds your contact details because you are someone we engage with as part of our work on the National Professional Enquiry Project (NPEP). Bangor University will only use your email address and telephone number for the purposes of this research, to contact you to arrange an interview.

No identifiable personal data or the names of schools will be collected as part of this and as part of completing the survey neither your email address nor your IP address are captured automatically so your responses are anonymous. Participation is entirely voluntary, and you are free to opt out at any stage.

At the end of the survey there is an option to leave your contact details to take part in a further discussion about your NPEP experiences. This data will only be used to contact you for the further discussion and will be destroyed once data collection has been completed. This is recorded in a separate survey form so that your responses remain anonymous.

What is the lawful basis for using your data?

The lawful basis for processing information in this data collection exercise is our public task—that is, exercising our official authority to undertake the core role and functions of the Welsh Government.

Participation is completely voluntary. Taking part will help ensure the research project takes into account the views of a wide range of stakeholders, providing a deeper understanding of current trends and potential mechanisms for change.

How secure is your personal data?

Personal information provided to Bangor University is always stored on a secure server, stored behind a Microsoft 2-step authenticator system. The data can only be accessed by a limited number of researchers working on this project. Bangor University will only use this data for research purposes.





The survey is hosted by JISC online surveys and data will be held on JISC server, which is has a Cyber Essentials certification and is UK GDPR compliant.

Bangor University has procedures to deal with any suspected data security breaches. If a suspected breach occurs, Bangor University will report this to the Welsh Government, who will notify you and any applicable regulator where there is a legal requirement to do so.

The final report will be published by the Welsh Government. This report will not include any information that could be used to identify individual participants.

How long do we keep your personal data?

Bangor University will hold personal data during the contract period, and any personal data not already removed will be deleted by Bangor University three months after the end of the contract. This includes your contact details.

The anonymised data will be provided to the Welsh Government and may then be shared with relevant stakeholders, such as researchers or education bodies, to support further research and development initiatives. However, it will not be possible to identify individual participants or schools from this information.

Individual Rights

Under UK GDPR, you have the following rights in relation to the personal information you provide as part of this advisory panel:

- Access a copy of your data.
- Rectify inaccuracies in your data.
- Object to or restrict data processing in certain circumstances.
- Request data erasure in certain circumstances.
- Lodge a complaint with the Information Commissioner's Office (ICO).
